PROMOTIONAL DRAWING RULES AND PROCEDURES

Name of Drawing or Promotion: **Mountain West Basketball Trip Giveaway**

Type of Drawing or Promotion: Promotional Drawing (Section 4.10)

Purpose of the Drawing or Promotion:

To bring added value, more excitement, and increase membership and participation in the NMLA VIP Club and the Points and Rewards Promotion.

Method:

- One (1) Drawing will be conducted by Scientific Games International (SGI) Drawing Services
1. One (1) ENTRY will be selected to win a five (5) day and four (4) night trip to attend the Men’s and Women’s Mountain West Conference Basketball Tournament March 8, 2017 through March 12, 2017 in Las Vegas, NV. (The “Trip Package” is valued at approximately four thousand four hundred fifty dollars (\$4,450)).
 2. Ten (10) alternates will be selected.

Entry Period and Entry Deadline:

Entry period begins Sunday January 15, 2017, at 12:00:00 AM MT.

Entry deadline is Saturday, February 4, 2017 at 23:59:59 PM MT.

Entry eligibility will be determined by the Scientific Games International Drawing Services System Time/Date Stamp.

Date and Time of the Drawing: Monday, February 6th, 2017 after 10:00:00 AM (MT).

Eligibility Requirements:

1. New Mexico Lottery VIP Club members who enter non-winning one dollar (\$1), two dollar (\$2), and three dollar (\$3) NMLA SCRATCHER tickets in the New Mexico Lottery Points and Rewards Promotion will receive one (1) entry for each entry submitted during the promotion period.
2. Players must enter the Points and Rewards Promotion at nmlottery.com through the Points and Rewards Promotion Tab.
3. Players that are not members of the New Mexico Lottery VIP Club may join at no cost at nmlottery.com and enter non-winning one dollar (\$1), two dollar (\$2), and three dollar (\$3) NMLA SCRATCHERS in the Points and Rewards Promotion to receive entries.
4. The selected VIP Club member (See Eligibility Requirements #1) must submit a completed NMLA Claim Form to the NMLA for verification within two (2) business days of receipt of notification.

Prize Details (Trip Package):

1. Five (5) day and four (4) night trip for two (2) to Las Vegas, Nevada.
2. Two (2) tickets to the Men's and Women's Mountain West Conference Basketball Tournament at the Thomas & Mack Center in Las Vegas, Nevada Wednesday March 8, 2017 through Saturday, March 12, 2017 (valued at approximately two hundred fifty dollars (\$250)).
3. Two (2) round-trip airline tickets (seats) from the major airport closest to the winner's residence to Las Vegas, NV (valued at approximately one thousand six hundred dollars (\$1,600)).
4. Accommodations for two (2) (double occupancy) at a Las Vegas, NV hotel for four (4) nights (valued at approximately twenty-one hundred dollars (\$2,100)).
5. The winner will receive five hundred dollars (\$500) in spending money.

Selected ENTRY Notification:

The NMLA EVP of Security will forward the information of the selected VIP Club member's ENTRY to the NMLA Second Chance Drawing Notification Distribution Group by 3:00:00 PM (MT) the day of the drawing. The selected VIP Club member will be notified as stipulated in the NMLA General Drawing Rules and Procedures for Second-Chance Drawings and Promotional Drawings.

Miscellaneous:

1. Exceptions or modifications to these rules must be approved in writing by the CEO and the Executive Vice President of Security or designees.
2. There is no cash value or substitutions for the Trip Package.
3. The Trip Package is transferable as long as the NMLA has the name and contact information of the two (2) people taking the Las Vegas trip within five (5) business days upon lottery claim form verification.
4. The airfare is nontransferable after the airline tickets have been booked.
5. The Trip Package does NOT include any ground transportation, gratuity, meals, or other amenities.
6. If the trip winners want to attend any of the basketball games prior to March 8, 2017 they are responsible for their own lodging.
7. Airfare, tickets and hotel will be provided by KRQE TV.
8. KRQE TV will mail a Form 1099 to the VIP Club member that submitted the claim form for verification.
9. The Lottery reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these Rules and Procedures.
