**PROMOTIONAL DRAWING RULES AND PROCEDURES**

Name of Drawing or Promotion: 2019 New Orleans Jazz Festival Trip

Type of Drawing or Promotion: Promotional Drawing (Section 4.10)

Purpose of the Drawing or Promotion:

1. To bring added value and generate more excitement for members of the New Mexico Lottery My Rewards program.

Method:

1. One (1) drawing will be conducted.
2. One (1) entry will be selected to win a trip for two (2) to New Orleans, LA for the 2019 Jazz Festival (Trip Package).
3. Ten (10) alternates will be selected.

Entry Period and Entry Deadline:

1. Entry period begins Tuesday, January 1, 2019 at 12:00:00 AM MT.
1. Entry deadline is Thursday, January 31, 2019, at 11:59:59 PM MT.
2. Entry eligibility will be determined by the My Rewards promotion Time/Date Stamp.

Date and Time of the Drawing: Wednesday, February 6, 2019 after 10:00:00 AM (MT), or as soon as practical.

Eligibility Requirements:

1. Players must be members of the New Mexico Lottery My Rewards program. All eligibility requirements in the Rules for the New Mexico Lottery My Rewards program will pertain to this promotional drawing.
2. Players that are not members of the New Mexico Lottery My Rewards program may join at no cost at [nmlottery.com](http://nmlottery.com).
3. Players must enter eligible non-winning NMLA Scratchers and/or eligible winning and non-winning Roadrunner Cash and Pick 3 tickets into the My Rewards program at [nmlottery.com](http://nmlottery.com) to receive entries. Players must then immediately choose to have entries assigned to the "2019 New Orleans Jazz Festival" drawing bucket.

Prize Details (Trip Package):

1. The Trip Package is valued at approximately three thousand dollars (\$3,000) and includes the following:
  - a. Six (6) day and five (5) night trip to New Orleans, Louisiana.
  - b. Two (2) round-trip airline tickets (seats) from the major airport closest to the winner's residence to New Orleans, Louisiana.
  - c. Accommodations for two (2) (double occupancy) at a New Orleans hotel for five (5) nights.
  - d. New Orleans Jazz and Heritage Festival 2019 passes:

- (1) Weekend 1: Two (2) three (3) day passes from Friday, April 26, 2019 through Sunday, April 28, 2019.
- (2) Weekend 2: Two (2) four (4) day passes Thursday, May 2, 2019 through Sunday, May 5, 2019.
- e. "New Orleans Pass" (a sightseeing package) for two (2) for one (1) day.
- f. Five hundred dollars (\$500) in spending money.

Drawing Procedures:

1. The administrator of the My Rewards program will provide NMLA Security a list of entries submitted for the entry period.
2. The pre-approved NMLA Promotional Drawing Procedures will be utilized for the drawing.
3. The NMLA Security Drawing Representative will conduct one (1) drawing, using a random number generator to select one (1) Trip Package winner.
4. Ten (10) alternates will be selected.

Selected Entry Notification:

1. The My Rewards selected entrant will be notified using the email address on his/her My Rewards account. The NMLA may attempt to notify the selected entrant by phone in addition to the email.
2. The selected My Rewards entrant will have five (5) business days to return the NMLA Claim Form from the date of initial notification.
3. If the My Rewards selected entrant does not return the completed NMLA Claim Form within five (5) business days from the date of initial notification, he/she will forfeit the prize and the first alternate will be contacted and the same process will be followed.
4. After the My Rewards selected entrant's claim form has been verified by the NMLA, KRQE Media Group (KRQE) will be provided the selected entrant's name and contact information as soon as possible.
5. KRQE will coordinate with the My Rewards selected entrant to complete the KRQE Trip Package paperwork, including issuing the W-9. The KRQE Trip Package paperwork must be completed within five (5) business days from the date of receipt by the selected entrant.
6. If the My Rewards selected entrant fails to return the KRQE Trip Package paperwork to KRQE in the designed timeframe, he/she will forfeit the prize and the first alternate will be contacted and the same process will be followed.

Miscellaneous:

1. Exceptions or modifications to these rules must be approved in writing by the CEO and the Executive Vice President for Security.
2. There is no cash value or substitutions for the Trip Package.
3. The selected entrant must select Weekend 1 or Weekend 2 when he/she completes the KRQE Trip Package paperwork.
4. The Trip Package is non-transferable.
5. The My Rewards selected entrant, upon submitting the NMLA Claim Form, is responsible for all federal and state taxes associated with the Trip Package.
6. If the Trip Package winner elects not to take the trip, a proxy maybe appointed prior to KRQE booking the reservations. Once travel arrangements are booked by KRQE the 2019 New Orleans Jazz Festival trip cannot be changed.
7. KRQE will provide the appropriate federal and state IRS Tax Forms to the Trip Package winner.
8. The Trip Package reservations must be finalized with KRQE a minimum of sixty (60) days prior to the date of travel. The person taking the Trip Package is responsible for any additional expenses, if any, changes are made to these dates after booking.
9. It is the responsibility of the selected entrant to contact KRQE/Ronn Weese at 505.764.5262 or by email at [ronn.weese@krqe.com](mailto:ronn.weese@krqe.com) with the names and birth dates of both persons traveling. The TSA requires the same names that are on the driver's licenses or picture IDs be on the airfare tickets.
10. The Trip Package does NOT include any additional ground transportation, gratuity, meals, or other amenities.

11. The person taking the 2019 New Orleans Jazz Festival trip must present his/her credit card for check-in at the hotel to cover any incidental expenses.
12. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these Rules and Procedures.
