

**RULES FOR THE
THE NEW MEXICO LOTTERY POINTS & REWARDS PROMOTION**

The New Mexico Lottery Authority (NMLA) will conduct the New Mexico Points & Rewards Promotion (Promotion) under the rules provided in this document. The Instant Tickets (SCRATCHERS) included in the Promotion are the one dollar (\$1), two dollar (\$2), and three dollar (\$3) price point scratcher games authorized for sale during the term of the Promotion. The Points & Rewards promotion will run from January 8, 2015 through January 9, 2016.

AMENDMENT I

Pursuant to and authorized by the NMLA General Drawing Rules and Procedures approved and adopted by the NMLA Board of Directors on April 9, 2015, the following sections of "Rules for the New Mexico Lottery Points & Rewards Promotion" have been amended:

- The promotion period has been extended through March 31, 2016.
- Section 2. Drawings. 3 additional drawings have been added.

AMENDMENT 2

Pursuant to and authorized by the NMLA General Drawing Rules and Procedures approved and adopted by the NMLA Board of Directors on April 9, 2015, the following sections of "Rules for the New Mexico Lottery Points & Rewards Promotion" have been amended:

- The promotion period has been extended through January 10, 2017
- Section 2. Drawings. 9 additional drawings have been added.
- Periodic promotions will offer players a chance to multiply their entries on selected games.

AMENDMENT 3

Pursuant to and authorized by the NMLA General Drawing Rules and Procedures approved and adopted by the NMLA Board of Directors on April 9, 2015, the following sections of "Rules for the New Mexico Lottery Points & Rewards Promotion" have been amended:

- Section 1. Entry - B, J and K. Clarification
- Section 3. Winner Notification – A and B, Clarification
- Section 5. Miscellaneous – B. Clarification

1. ENTRY

- A. To be eligible to enter the Promotion an entrant must be at least eighteen (18) years of age and submit an eligible entry.
- B. An "Eligible Entry" is limited to a non-winning SCRATCHER Ticket available for purchase during the Promotion. Players must be members of the NMLA VIP Club to submit an entry. Players must enter their first and last name, street address (including city, state, and zip code), best contact telephone number(s) or email address, and confirmation that they are at least eighteen (18) years of age.
- C. Eligible SCRATCHERS must be entered by clicking on the Points & Rewards link at www.nmlottery.com. Mail-in Entries will not be accepted for entry and will not be returned to the sender.
- D. Eligible SCRATCHERS are limited to non-winning one dollar (\$1), two dollar (\$2), and three dollar (\$3) SCRATCHERS available for purchase during the Promotion, with the exception of games that have an Announced End of Game Date.

- E. Players are not required to retain the SCRATCHER entered for verification.
- F. Eligible SCRATCHERS can only be entered into the Promotion one (1) time.
- G. Players may only enter twenty (20) eligible SCRATCHERS per day. The clock starts at 12:00:00 AM MT and ends at 11:59:59 PM MT. (See the Draw Schedule on page 2)
- H. Players must enter the three-digit game number (GGG), six digit pack number (PPPPPP), the three-digit ticket number (TTT), the eight-digit encrypted validation number/prizes code (VVVVVVVV), and two-digit check code (CC). Once the mobile app has launched, players shall be able to scan the barcode printed in the play area under the latex scratch surface.
- I. Players will receive ENTRIES, based on the price point of the SCRATCHER entered.

- J. Periodic promotions will offer players a chance to multiply their entries on selected games. Website banners and VIP Club messages will give players promotion details.
- K. All required information must be submitted for the entry to be eligible. Once the electronic entry system accepts the required ticket information, the same ticket information will not be accepted a second time for the duration of the Promotion. The NMLA is not responsible for mis-delivery, late delivery, or the failure of receipt of any required information, regardless of the cause of the failure of transmission.
 - i. Entries that fail to provide the required information will be disqualified
 - ii. Entries submitted after the monthly draw deadline will be entered in the next draw, if a draw remains.
 - iii. Entries submitted after the deadline for the final draw will be discarded.
- L. Players do not need to retain the SCRATCHER tickets they entered. Winners are not required to produce the selected ticket for verification.

2. DRAWINGS

- A. Entries must be received no later than 11:59:59 PM MT on the entry deadline dates listed below. An entry submitted during a respective entry period is only eligible for the corresponding Draw Date and an entry does not carry forward as an entry in a subsequent Monthly Draw. - B. Each Draw will be conducted at Scientific Games International (SGI) offices located in Alpharetta, Georgia, as specified in the Draw Procedures. The time and place for a Draw may be established or changed without notice or amendment to these Rules.
- C. In each Monthly Drawing one (1) player shall be selected to win five thousand dollars (\$5,000) (Cash Prizewinner).
- D. In each Monthly Drawing three hundred (300) players shall be selected to earn points in lots of 2,500, 5,000, 10,000 and 20,000 (Merchandise Points Prizewinner). Merchandise Points Prizewinners may redeem their points in the merchandise prize store.

- F. In each Monthly Drawing three hundred (300) alternates will be selected.
- Ten (10) Alternates will be selected immediately after the Cash Prizewinner has been selected. They will be the Alternates for the Cash Prizewinner.
 - Two hundred-ninety (290) Alternates will be selected after the Merchandise Points Prizewinners have been selected. They will be the Alternates for the Merchandise Points Prizewinners.
 - In the event a Cash Prizewinner Alternate is selected as a Merchandise Point Prizewinner that Cash Prizewinner Alternate will be disqualified.
- G. A player may qualify as a prizewinner only one (1) time in each Monthly Draw. A player is eligible to win in another Monthly Draw.

3. WINNER NOTIFICATION

- A. The Merchandise Points Prizewinners will be notified via email using the email address on file in the NMLA VIP Club account. The points won will be automatically credited to their NMLA VIP account within 48 hours after the drawing and posted to the Points and Rewards website, barring any technical difficulties. Players can log onto their NMLA VIP account and will be able to see their available Merchandise Points, if any.
- B. The Cash Prizewinner will be sent an NMLA Claim Form via email, certified mail, or via commercial overnight delivery service to the email address or physical address on file in the NMLA VIP Club account. The NMLA must receive the completed claim form with all the information required by the NMLA by close of business on the date and time specified by the NMLA. If the completed claim form and other information requested are not received by the date and time specified, the winner may be disqualified. The NMLA assumes no responsibility for incorrect addresses, mis-delivery, late delivery, or failure of delivery for any reason for any item(s) sent pursuant to this paragraph by either the NMLA or the winner, regardless of fault. All risk of loss remains with and is assumed by the selected entrant.
- C. If any of the Prizewinners are disqualified, for any reason, an alternate will be contacted and the same process will be followed. Once the decision to proceed with an alternate is made, the person who was previously selected as the winner is no longer entitled to the prize and is not entitled to relief.

4. POINTS & PRIZES

Points are not transferable, and no substitutes for prizes are available, except by the NMLA, which reserves the right, in its sole discretion, to substitute different prizes of comparable value. The NMLA's decisions shall be final and conclusive in all matters relating to the Promotion. Cash Prizewinners will be responsible for any additional federal and state tax withholdings, and other legally required withholdings. Prizewinners will be required to furnish their social security numbers for federal and state tax reporting and withholding. All points will expire ninety (90) days after the last drawing.

5. MISCELLANEOUS

- A. All decisions by the NMLA are final.
- B. The Merchandise Points have no cash value and can only be used to acquire merchandise from the New Mexico Lottery Points & Rewards Store. Additional points cannot be purchased.
- C. Amendments to these rules, including cancellation of the Promotion, may be made at any time without notice, but must be made in writing and signed by the NMLA Chief Executive Officer (CEO). - D. By submitting an entry, an entrant is bound by the official rules of this Promotion.
- E. Prizes will not be mailed outside the United States.
- F. The NMLA may use, without limitation, an entrant's hometown, name, likeness, and/or voice in any promotion, research, marketing, publications or other advertising media including, but not limited to, the NMLA website without compensation.
- G. The odds of being selected or not being selected in the Promotion depend on the number of entries submitted for each of the draws.
- H. Prizewinners will receive a W-2G tax form for the "fair market value" of any prize valued over six hundred dollars (\$600.00).
- I. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- J. The New Mexico Lottery Act and the Points & Rewards Rules shall govern this promotion. In the event of a conflict among these documents, the New Mexico Lottery Act shall prevail.
- K. Copies of these rules are available at nmlottery.com and/or the NMLA Claim Center.
- L. An entry may not be submitted by the following:
 - Any member of the NMLA Lottery Board;
 - Any officer or employee of the NMLA;
 - An owner, officer or employee of a lottery vendor directly servicing the NMLA account;
 - Individuals residing in the primary place of residence of a NMLA Lottery employee, or NMLA Lottery Board Member.
