## SUBJECT: Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for March 2020 (FY 2020) is \$2,964,025 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2020 proceeds total \$27,621,519, compared to \$33,218,119 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by April 30, 2020.
