SUBJECT: Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for June 2017 (FY 2017) is \$3,044,533 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2017 proceeds total \$37,835,459, compared to \$46,324,157 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by July 31, 2017.
