The amount of estimated revenues transferred for November 2019 (FY 2020) is \$3,496,531 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2020 proceeds total \$15,377,137, compared to \$18,661,782 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by December 31, 2019.
