
Starting from Scratch

In its first year of operation, the New Mexico Lottery generated revenues of \$87.5 million through the sale of instant scratch-off tickets and "on-line" tickets used in computerized games. Scratchers, were introduced on the Lottery's first day of sales, April 27, 1996. The on-line game of **POWERBALL** followed on October 20, with **Daily Millions**, another on-line game, starting on February 16, 1997.

Dividing the Dollar

The Lottery returns a minimum of 50 percent of proceeds to players in the form of prizes. Funds are also allocated to cover the cost of product, as well as retailer commissions and administrative costs. Once these expenses have been covered, the Lottery turns over all net proceeds to the State Treasurer for use in funding education in New Mexico.

Funding Our Children's Future

The New Mexico Lottery raised \$21 million in net proceeds for New Mexico education in its first year of operation. Of this amount, 60 percent went to the state's public school capital outlay fund, which benefits educational and capital projects ("bricks and mortar") for grades K-12. The remaining 40 percent of net proceeds went to the state's lottery tuition fund, which provides tuition assistance ("Lottery Success Scholarships") to New Mexico residents for public post-secondary education in New Mexico.

Success Scholarships for New Mexico Students

In August 1997, the New Mexico Commission on Higher Education will begin awarding tuition scholarships to an estimated 3,100 full-time students entering their sophomore year at New Mexico public post-secondary institutions.

The Program Features Include:



100 percent tuition funding



eight consecutive semesters of eligibility beginning with the *second* semester of college enrollment



no application required

To Qualify for a Scholarship, Students Must:



graduate from a New Mexico high school or earn a New Mexico General Equivalency Diploma (GED)



enroll full-time in a New Mexico public, postsecondary institution in the first regular semester following high school graduation, and pay the tuition for that semester




earn a 2.5 GPA in the first semester
