SUBJECT: Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for January 2021 (FY 2021) is \$6,950,766 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2021 proceeds total \$27,155,910, compared to \$21,922,352 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by February 26, 2021.
