

# New Mexico Lottery Authority Second-Chance Drawing Rules

## EVERLASTING MILLION Second-Chance Promotion

**THE NMLA AT ITS SOLE DISCRETION MAY TERMINATE, END, OR CANCEL THIS PROMOTION AT ANY TIME.**

**PROMOTION AND RULES ARE SUBJECT TO CHANGE AT THE NMLA'S DISCRETION AT ANY TIME.**

### 1. Promotion Description

- a. The New Mexico Lottery Authority (NMLA) will conduct the EVERLASTING MILLION Second-Chance Promotion (Promotion) according to these rules and the Second-Chance and Promotional Drawing Rules available at [nmlottery.com](http://nmlottery.com) or the NMLA Claims Center.
- b. One (1) drawing will be held:
  - i. One (1) player will be selected to win a trip to Las Vegas, Nevada (Trip Prize) to play the EVERLASTING MILLION CHALLENGE™ (Challenge).

### 2. Entry Period, Deadline, and Drawing Date

- a. Entry period begins Tuesday, June 29, 2021 at 12:00:00 AM MT.
- b. Entry eligibility will be determined by the time/date of successful submission into the entry website for the Promotion.
- c. The Entry Deadline Date and the Drawing Date will be posted on the entry website once determined.

### 4. Eligibility Requirements

- a. Players must certify that they are at least eighteen (18) years of age.
- b. Players must enter through the My Rewards program at [nmlottery.com](http://nmlottery.com).
- c. Players that are not members of the My Rewards program may join at [nmlottery.com](http://nmlottery.com).
- d. Players must manually enter a non-winning ticket from Game #472 WILLY WONKA GOLDEN TICKET™ or use the NM Lottery Play Again App to scan the ticket.
  - i. For manual entry, enter the twelve (12) digit ticket number located on the back of the ticket above the barcode and the ten (10) digit entry number located on the front of the ticket, underneath the scratch-off coating, or
  - ii. For mobile device entry, scan the barcode located on the front of the ticket, underneath the scratch-off coating.
- e. A pre-determined number of Promotion entries are assigned to each eligible ticket. Upon entry, players will receive the number of entries assigned to that ticket.
- f. Players may submit multiple entries. However, each ticket may only be entered once.
- g. Players may enter up to fifty (50) tickets per day.
- h. Entries mailed or hand delivered to the NMLA will be disqualified and will not be returned.

## **5. Trip Prize Details**

- a. The Trip Prize is valued at approximately seven thousand five hundred dollars (\$7,500) including federal and state withholding taxes.
- b. Each Trip Prize includes:
  - i. Four (4) day, three (3) night trip for two (2) people to Las Vegas, NV in or about the summer of 2022;
  - ii. Roundtrip coach-class airfare for two (2) people (two (2) seats) from the major airport nearest the winner's city to McCarran International Airport in Las Vegas;
  - iii. Ground transfers between McCarran International Airport and the destination hotel and between SGI hosted events, if such transportation is reasonably required;
  - iv. Three (3) nights' hotel accommodations in Las Vegas (one (1) double occupancy hotel room and tax only);
  - v. One thousand dollars (\$1,000) spending money for the Trip Prize winner (Winner);
  - vi. Admission to the Challenge venue for the Winner and guest;
  - vii. The Winner (or assigned proxy) shall have a chance to participate in the Challenge together with winners from other participating lottery jurisdictions.
    1. Winner will be mailed Challenge Rules and details prior to the trip departure.
    2. Winner's guest may sit with the Winner but will not be eligible to be a participant in the Challenge, unless they have been designated as a Winner's proxy.

## **6. Drawing Procedures**

- a. SGI Drawing Services shall receive and securely store electronic entries for the Trip Prize. One (1) second-chance drawing will be conducted by SGI Drawing Services according to the Scientific Games – New Mexico Lottery Authority Generic Second Chance Drawing Procedures.
- b. Ten (10) alternates will be selected.

## **7. Selected Entry Notification**

- a. The Procedures for Notification of Selected Entries of Second Chance or Promotional Drawings will be followed.
- b. The selected entrant will be notified using the email address and phone number (if available) on his or her My Rewards account.
- c. The selected entrant must submit a completed NMLA Claim Form within the time frame specified by the NMLA for verification. Failure to submit the completed NMLA Claim Form in the designated timeframe may result in disqualification, in which case the first alternate will be contacted, and the same process will be followed.

## **8. Miscellaneous**

- a. Exceptions or modifications to these rules must be approved in writing by the NMLA CEO and the NMLA EVP for Security.
- b. Upon submitting an entry, the player(s) agree that the NMLA may use their name, voice, photograph, video, any social media postings, and/or likeness in any form for the purpose of advertising and/or publicizing the NMLA.
- c. The Winner, upon submitting the NMLA Claim Form, is responsible for all federal and state taxes associated with the Trip Prize and Challenge.

- d. SGI shall withhold and deposit the minimum required federal tax withholdings and any applicable state tax withholdings on behalf of the Winner. SGI shall provide an IRS Tax Form W-2G form to the Winner.
- e. No compensation will be paid in lieu of any cancelled event or any other element of the Trip Prize.
- f. Upon claim form verification, the Winner's name and information will be given to SGI for Trip Prize fulfillment.
- g. The Winner must be twenty-one (21) or older to participate in the Challenge. If the Winner is not twenty-one (21) or older, a proxy must be designated to participate in the Challenge on his or her behalf.
- h. The Winner may pre-designate a proxy to participate in the Challenge on his or her behalf. A proxy must be at least twenty-one (21) years of age. The Winner shall receive any cash prizes won by the proxy during the Challenge.
- i. Because the age requirement to check into a hotel in Las Vegas is twenty-one (21), either the Winner or guest must be at least twenty-one (21) years old to check into the hotel.
- j. It is the responsibility of the Winner and guest to comply with the REAL ID Act to the extent such Act is applicable to the Winner's and guest's air travel.
- k. The Winner and guest are subject to a background investigation prior to the Trip Prize.
- l. At the discretion of the NMLA or SGI, a proxy may be appointed to represent the Winner.
- m. Only the Winner is eligible to win a Challenge prize. The Winner's guest or proxy is not eligible to win a Challenge prize.
- n. The Winner is solely responsible for the actions of his or her guest. If the guest is a minor, the Winner must either be the parent or legal guardian of such guest or must present a notarized, written consent from the minor's parent or legal guardian for the minor guest to accompany the Winner on the Trip Prize trip.
- o. If the Winner elects not to take the trip, elects to not take a guest, or whose guest, for any reason, does not actually take the trip, then the Winner is still subject to the full amount of any taxes due on the total value of the Trip Prize.
- p. The Trip Prize does not include mileage, insurance, gratuities, meals, parking fees, baggage fees, alcoholic beverages, personal expenses such as telephone calls, valet service, laundry, incidentals and the like, revision or cancelation fees which may be charged by the hotel or other suppliers, or any other items not expressly specified herein.
- q. Winner will be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the Trip Prize.
- r. No prize element substitution, cash substitution, assignment, or transfer of the Trip Prize or any elements thereof is permitted. Any unused elements of the Trip Prize will be forfeited, will not be redeemable for cash, and will not reduce the prize value awarded for tax purposes.
- s. The Winner is subject to travel requirements provided by SGI. The Winner may forfeit any or all of the travel portion of the Trip Prize if the Winner misses his or her flight, fails to check in to the participating hotel, or otherwise fails to arrive at a scheduled participation time, including the Challenge. In such case, the NMLA or SGI shall appoint a proxy to play the Challenge for the Winner, and the Winner shall receive any prize won by the proxy.
- t. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- u. Failure to provide accurate information could cause a player selected as a drawing winner to be disqualified.

- v. Use or distribution of “auto” software programs or other similar software programs or applications to enter ticket or ticket codes into any drawing is prohibited. If discovered to be using such a program or application, a player’s entries may be disqualified.
- w. Void where prohibited by law.
