The amount of estimated revenues transferred for June 2022 (FY 2022) is \$3,394,398 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2022 proceeds total \$41,071,408, compared to \$46,481,668 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by July 29, 2022.
