New Mexico Lottery Authority Second-Chance Drawing Rules

Mega Millions Bonus Promotion

THE NMLA AT ITS SOLE DISCRETION MAY END OR CANCEL THIS PROMOTION AT ANY TIME. PROMOTION AND RULES ARE SUBJECT TO CHANGE AT THE NMLA'S DISCRETION AT ANY TIME.

1. Promotion Description

- a. The New Mexico Lottery Authority (NMLA) will conduct the Mega Millions Bonus Promotion (Promotion) according to these rules, the New Mexico Lottery Promo Zone Program Rules, and the Second-Chance and Promotional Drawing Rules.
- b. Five (5) drawings will be conducted:
 - i. In four (4) Weekly Drawings, ten (10) entries will be selected to each win one thousand dollars (\$1,000).
 - ii. In the Grand Prize Drawing, one (1) entry will be selected to win ten thousand dollars (\$10,000).

2. Entry Periods, Deadlines, and Drawing Dates

- a. Entry period begins Monday, January 30, 2023, at 12:05 AM MT.
- b. Entries must be received no later than 11:59:59 PM MT on the Entry Deadline Date listed in the Entry and Draw Schedule below.
- c. Entry eligibility will be determined by the time/date of successful submission into the entry website for the Promotion.
- d. Drawings will be held after 10:00 AM MT on the dates below, or as soon as practical.

3. Location of Drawing

4. Eligibility Requirements

a. Players must certify that they are at least eighteen (18) years of age.

- b. Players must enter through the Promo Zone program at nmlottery.com.
- c. Players that are not members of the Promo Zone program may join at nmlottery.com.
- Players must purchase a minimum of six dollars (\$6) in New Mexico Lottery Mega Millions on one (1) ticket during the entry period to receive a Mega Millions Bonus Promotion Entry Coupon (Entry Coupon) with an eight (8) digit serial number.
- e. The six-dollar (\$6) or more purchase can include a combination of multiple plays or multi draws as long as they are on one (1) ticket. Just the Jackpot plays print on separate tickets and cannot be combined with standard Mega Millions plays to form a six-dollar (\$6) purchase combination on a single ticket. Players may purchase six dollars (\$6) or more of Just the Jackpot on one (1) ticket during the entry period to receive an Entry Coupon.
- f. Players will receive two (2) Entry Coupons with a ten-dollar (\$10) through fourteen-dollar (\$14) purchase. Any incremental purchases of an additional five dollars (\$5), on one (1) ticket, will generate an additional Entry Coupon (i.e. three (3) Entry Coupons with a fifteen-dollar (\$15) purchase, four (4) Entry Coupons with a twenty-dollar (\$20) purchase, etc.)
- g. Players must enter the eight (8) digit serial number from an eligible Entry Coupon onto the applicable entry webpage of the Promo Zone accessible via nmlottery.com.
- h. All required information must be submitted for the entry to be eligible. The NMLA is not responsible for mis-delivery, late delivery, or the failure of receipt of any required information, regardless of the cause of the failure of transmission.
- i. The Entry Coupon is a bearer instrument. Players MUST sign and keep their Entry Coupon and present it, if selected as a winner.
- j. Players may submit multiple Entry Coupon serial numbers. However, each Entry Coupon serial number may be only entered one (1) time during the Promotion.
- k. Players may win only one (1) time in each drawing but can win in any of the five (5) drawings.
- I. Entry Coupons not selected as winners in the four Weekly Drawings are eligible to win the Grand Prize Drawing.
- m. Players may enter up to fifty (50) Entry Coupons per day.
- n. Entries mailed or hand delivered to the NMLA will be disqualified and will not be returned.

5. Prize Details

- a. The forty (40) Weekly Drawing winners will each receive one thousand dollars (\$1,000).
- b. The one (1) Grand Prize Drawing winner will receive ten thousand dollars (\$10,000).

6. Drawing Procedures

- a. An NMLA Security representative will conduct the five (5) drawings, as indicated on the Entry and Draw Schedule, using a random number generator.
- b. Ten (10) entries will be selected in each of the four (4) Weekly Drawings. Twenty (20) alternates will be selected in each of the four (4) Weekly Drawings.
- c. One (1) entry will be selected in the Grand Prize Drawing. Ten (10) alternates will be selected in the Grand Prize Drawing.
- d. If an entry selected in the Grand Prize Drawing won a prize in a Weekly Drawing, then that selected entry will be disqualified.

7. Selected Entry Notification

a. The Procedures for Notification of Selected Entries of Second-Chance or Promotional Drawings will be followed.

- b. A selected entrant will be notified using the email address on file in the Promo Zone. In addition to the email, the NMLA may attempt to notify a selected entrant by phone.
- c. A selected entrant must acknowledge receipt of the email or phone call and/or submit the signed Entry Coupon and a completed NMLA Claim Form within the timeframe specified by the NMLA. Failure to submit the signed Entry Coupon and the completed NMLA Claim Form in the above designated timeframe may result in disqualification, in which case the first alternate will be contacted, and the same process will be followed.

8. Miscellaneous

- a. Exceptions or modifications to these rules must be approved in writing by the NMLA CEO and the NMLA EVP for Security.
- b. The winners will receive an IRS Form W-2G.
- c. The NMLA will withhold and deposit the minimum required federal tax withholdings and any applicable state tax withholdings on behalf of the Grand Prize Drawing winner.
- d. Failure to provide accurate information could cause a player selected as a drawing winner to be disqualified.
- e. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- f. Upon submitting an entry, the player(s) agree that the NMLA may use their name, voice, photograph, video, any social media postings, and/or likeness in any form for the purpose of advertising and/or publicizing the NMLA.
- g. Use or distribution of "auto" software programs, or other similar software programs or applications to enter tickets or ticket codes into any drawing is prohibited. If discovered to be using such a program or application, a player's entries may be disqualified.
- h. Void where prohibited by law.
