## **SUBJECT:** Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for January 2023 (FY 2023) is \$5,486,469 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2023 proceeds total \$32,268,250, compared to \$24,549,907 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by February 28, 2023.
