The amount of estimated revenues transferred for September 2023 (FY 2024) is \$3,940,393 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2024 proceeds total \$14,580,222 compared to \$12,346,772 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by October 31, 2023.
