## **SUBJECT:** Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for March 2024 (FY 2024) is \$5,272,137 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2024 proceeds total \$39,686,978 compared to \$39,842,312 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by April 30, 2024.
