

New Mexico Lottery Authority Promotional Drawing Rules

Legends of Lucha Libre® Event

THE NMLA AT ITS SOLE DISCRETION MAY END, OR CANCEL THIS PROMOTION AT ANY TIME. PROMOTION AND RULES ARE SUBJECT TO CHANGE AT THE NMLA'S DISCRETION AT ANY TIME.

1. Promotion Description

- a. The New Mexico Lottery Authority (NMLA) will conduct a Legends of Lucha Libre® Event Promotion (Promotion) according to these rules and the Second-Chance and Promotional Drawing Rules.
- b. The NMLA will host a Legends of Lucha Libre® wrestling event (the Event) on May 9, 2026, at the National Hispanic Cultural Center located at 1701 4th St. SW, Albuquerque, NM 87102, beginning at 2:00 p.m. MT. Admittance to the event requires a ticket.
- c. One (1) drawing will be held. Two hundred and sixty-five (265) winners will win up to two (2) tickets to attend the event.

2. Entry Period, Deadline, and Drawing Date

- a. Entry period begins Tuesday, April 7, 2026, at 12:00:00 AM MT.
- b. Entry deadline is Tuesday, April 21, 2026, at 11:59:59 PM MT
- c. The drawing will be held on Wednesday, April 22, 2026, after 10:00 AM MT, or as soon as practicable.
- d. Entry eligibility will be determined by the time/date stamp of a successful submittal of the digital submission form on the entry website for the Promotion.

3. Location of Drawing

The drawing will be held remotely by Alchemy3 using a certified random number generator.

4. Eligibility Requirements

- a. Entrants must be at least eighteen (18) years of age.
- b. Entrants must complete an electronic submission form available via the Promo Zone website at nmlottery.com to receive one (1) drawing entry.
- c. An entrant may only complete one (1) submission form.
- d. An entrant may only win one (1) time in the drawing.

5. Prize Details

- a. Each winner will receive up to two (2) tickets to the Event. The winner may select one (1) or two (2) tickets on the confirmation form.
- b. Additional prizes may be awarded at the event at the discretion of the NMLA.
- c. A winner's guest may be under the age of eighteen (18), but the guest must be accompanied by the winner.

6. Drawing Procedures

- a. Each entry will be sequentially numbered and stored in a secure file until the drawing date.

- b. Alchemy3 will conduct the drawing, as indicated in Entry Period, Deadline, and Drawing Date, using a random number generator.
- c. Two hundred and sixty-five (265) entries will be selected in the Drawing. All remaining entries will be selected as alternates and sequentially numbered.
- d. The odds of being selected in the Drawing depend on the number of entries received.

7. Selected Entry Notification

- a. All selected entrants will be notified using the email address entered at the time of submission. Alchemy3 may use additional contact options.
- b. Selected entrants must confirm attendance by Friday, April 24, 2026, 11:59:59 PM MT. Failure to confirm by the deadline may result in disqualification and the forfeiture of tickets. In that case, the first alternate will be contacted, and the same process will be followed.
- c. The total number of winners is two hundred sixty-five (265). The total number of desired attendees at the Event is five hundred thirty (530). If any winner selects only one (1) ticket, Alchemy3 may select additional winners in order of the alternate rank, with the goal to have five hundred thirty (530) tickets awarded.

8. Miscellaneous

- a. Exceptions or modifications to these rules must be approved in writing by the NMLA CEO and the NMLA EVP for Security.
- b. Upon submitting a submission form, the player(s) agree that the NMLA may use their name, voice, photograph, video, any social media postings, and/or likeness in any form for the purpose of advertising and/or publicizing the NMLA.
- c. The NMLA is not responsible for mis-delivery, late delivery, or the failure of receipt of any required information, regardless of the cause of the failure of transmission.
- d. If more than one name appears on an entry, the entry may be disqualified at the discretion of the NMLA.
- e. Additional drawings may be added, without amending these rules.
- f. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- g. Failure to provide accurate information could cause a player selected as a drawing winner to be disqualified.
- h. Use or distribution of "auto" software programs or other similar software programs or applications to enter tickets or ticket codes into any drawing is prohibited. If discovered to be using such a program or application, a player's entries may be disqualified.
- i. Void where prohibited by law.
